Terms and Conditions for Vending Form

1. Vendor's official hours are 10AM - 4PM. Vendors can begin setting up at 8:30AM. All tables and merchandise must be packed up and premise vacated no later than 5:30PM. The event is open to the public from 10AM to 4PM.
2. This agreement is solely binding to the use of vending/table space for 2018 Orlando Pagan Pride Day to be held on Saturday, September 29, 2018. Event location will be at the First Unitarian Church of

Orlando, 1901 E Robinson Street, Orlando, FL 32803. You may not use the space before or after the event.

3. Payments for vendor tables/booths are \$30 for a 10x10 spot outside or for a space up to an 8 foot table inside and \$55 for a double space. Payments can be paid for via PayPal. We will email you the PayPal invoice for you to use to pay for your booths.

4. Space is available on a first-come, first serve basis

5. All forms are due by May 31st, 2018 unless prior arrangements have been made.

6. You are required to provide everything you will need for your booth space, however there are a limited amount of tables available should you need one, please indicate this on the form and we will contact you about it. Chairs are available for both inside or outside vendors.

7. Orlando Pagan Pride Day, First Unitarian Church of Orlando, and affiliated sponsors are not liable for any theft, damage, tax collection or bookkeeping attributed to your vending activities.

8. Vendors agree to not sell any "illegal" items in their respective spaces. These may include but are not limited to: alcohol, adult material, drugs, weapons, or unauthorized use of copyrighted material. This is a family friendly event and we ask that you consider that there may be young children present at the event that will be visiting your booth.

9. The event host reserves the right to ask vendors to remove/change items and/or situations or to leave the premises without refund for any violations of this signed and executed contract.
